# Aurora Day at the Capitol

Aurora Day at the Capitol, organized by the City of Aurora and the Aurora Chamber of Commerce, will feature prominent political speakers, a visit to the House and Senate floor and a great deal of insight into the key issues confronting the members of the 2005 Legislature.

The day-long event is scheduled to begin at 7:30 a.m. in the Supreme Court Chambers of the Capitol Building on Colfax with a continental breakfast sponsored by FirstBank Holding Company, followed by a short welcome by Lt. Governor Jane Norton. In addition, Mayor Ed Tauer will host many members of the Aurora delegation who are expected to drop by and share their views of progress on key issues they are pursuing in 2005.

# President's Letter

#### 2005 Aurora Chamber of Commerce **Steps Outside the Box**

ow many times have you heard seminar speakers lecture about the importance of "thinking outside the box?" To do something new, exciting and thought provoking?

Well, this upcoming year, we absolutely have to "think," but actively "step" outside the box to take care of the multiple challenges we will be facing both on a local level and at the State Capitol.

In the broader scheme of things, it appears the country is on its way to a balanced, sustainable economic recoverv. Well-timed, well-prescribed tax cuts have begun to lift us out of our recession. We are seeing signs that the economy is now growing and beginning to create new jobs. This is remarkable considering what we have been up against during the last four years. There was an inherited recession, a busted tech bubble, corporate scandals, 9/11, war on two fronts and an oil price shock. Here in Colorado, though, we face our own challenges.

#### Community First... Business Always

That is the Aurora Chamber of Commerce 2005 theme. It reminds us that we face a number of daunting financial challenges in Colorado this year; challenges that demand we not sit back passively, but step up and actively look at all options. We need to step out of the box and consider these five

- 1. We need to make it clear to our state leaders at the Capitol that passing any meaningful legislation this year is impossible until they take care of TABOR and Amendment 23. It's the business community's number one priority to work with members of both parties to solve the state's budget and fiscal crisis.
- 2. The proposed Veterans Administration Hospital at Fitzsimons and the land challenges they have can be taken care of. Why not place the Hospital in an expanded area around the Fitzsimons Redevelopment Area? Ask Stapleton Redevelopment Authority to donate land across the street from Peoria Street for the Hospital, Seek innovative financing to purchase the land south of Fitzsimons in the Urban Renewal Area that the City of Aurora has established. Ask for another \$50 million in appropriations to buy the land for the Veterans who have risked their lives and limbs for this country. They deserve it and it's our responsibility to provide it for their sacrifices.
- 3. Start looking at 50-year bonding obligations instead of 30 years. Our allies from Europe and Asia have been doing this for years to take care of their transportation and infrastructure challenges.
- 4. We are all citizens of Colorado. Let's put aside our decades of fighting for water and work together to draft a bill that would compensate the

ranchers and farmers for the water they own. With conservation we have proven to our west slope neighbors that we can cut our water consumption and we will be good stewards of this valuable asset. If the Front Range economy falters because of a lack of sustainable water, the entire state will suffer from a dramatic loss in economic development.

5. We are all huge consumers. two-thirds of our economy. Continued consumer spending is crucial to our economic well-being. offices be from businesses here in the state. Remember your ABC's: Always Buy Colorado!!!!

#### All for One, and One for All

This is a team effort. Our success depends on acquiring the financial resources necessary to advance probusiness policies. It also depends on roots support for those policies. Large companies and small must be at the table. We can no longer afford to have some of our business community on the sidelines. We need the participation of ALL putting their resources to work. In this area we truly believe that your investment of time and money will help the Chamber play the role of coach and we step out of the box, our business community will be able to lead the charge for a climate in which economic be shy, don't keep quiet, step out of the

# E-470 opens new ramps at Chambers Road

# Ramps complete full interchange in Douglas County

The E-470 Public Highway

Authority opened new ramps on the east side of the Chambers Road bridge, west of Parker Road and east of Peoria Street in November. The westbound offramp will provide a direct route to the ComPark business center, American Furniture Warehouse and other business and residential areas on the north and south sides of E-470.

"Douglas County and E-470 entered into a partnership to add a second bridge and complete the ramps at Chambers Road," said Ed DeLozier, executive director of E-470.

"Intergovernmental cooperation has been very successful in completing this and other projects on E-470."

The eastbound on-ramp will yield easy access to E-470, Parker, and Aurora, as well as the Denver International Airport. The two new ramps on the east side of Chambers Road will have exact change coin baskets and will also accommodate EXpressToll customers. The toll on the westbound off-ramp and eastbound onramp will be \$.75.

# CDOT Commissioner cites shortfall

Colorado Department of Transportation Commission Chair Joe Blake told the Chamber Transportation Committee that state transportation funding needs as defined by the CDOT 2030 Plan fall nearly \$103 billion short of anticipated state budgets. Blake, who is also President of the Denver Chamber of Commerce, said this poses a tremendous challenge to the business community which depends on an adequate multimodal system to move goods services and people efficiently and economically. Blake blamed the shortfall on several years of funding limitations imposed by TABOR and unexpectedly high growth rates.

"We absolutely must keep the coalition of business and government

together if we are to get any new monies for transportation," he said in calling for greater regional cooperation among business entities, government agencies at all levels, and Chambers of Commerce. Blake said organizations like the Aurora Chamber-formed Eastern Metro Transportation

Authority (EMTraC) should work with other like organizations to track and lobby for increased transportation resources.

EMTraC will meet on Feb. 2 at 7:30 a.m. at Merrick & Company.
Guest speakers include Marge Klein from U.S. Representative Bob
Beauprez's office and representatives from the TransPort Project near Front Range Airport.

### Government Affairs Committee Gears Up for 2005 Legislative Session

The Chamber Government Affairs Committee has added an extra meeting each month through April. The committee, which has combined efforts with the Education Committee, will meet on the first and third Thursday of each month to more closely track activities and bills in the 2005 State Legislature.

Committee Chairs Dale Mingilton of FirstBank Holding Company and Dr. Linda Bowman of the Community College of Aurora have also been working with committee members to produce a series of White Papers on

issues vital to the Chamber membership. Topics covered include Economic Development, Health Care, Higher Education, K-12 Education, Initiatives, Legislative Mandates, Taxes, Transportation, and Water.

Recent speakers at Government

Affairs Committee meetings have included Henry Sobanet, the Governor's Budget Director; *Georgia Durán*, Communications Director for **Aurora Public Schools**; Susan Bachar of the Coalition to Support Colorado's Hospitals, and *Peter Binney*, Director of **Aurora Utility Department**.

Debbie Stafford (HD 40), Rep. Nancy Todd (HD 41) and Sen. Stephanie Takis (SD 25). Rep. Michael Garcia (HD 42), the new assistant majority leader in the House was unable to attend due to a previously scheduled meeting at the Capitol and Sen. Nancy Spence (SD 27) was out due to illness. A number of other elected officials were in attendance including Aurora Mayor Ed Tauer, Aurora City Council members Ingrid Lindemann, Sue Sandstrom, Bob Broom, Steve Hogan and Brad Pierce, as well as Centennial City Councilwoman Susan Nix, newly elected Arapahoe County Commissioner Frank Weddig and recently appointed State Board of Education member, Karen Middleton

The legislators laid out their plans for the session ahead and answered questions from the group. The next Legislator's breakfast is schedule for April 4 on the North Campus of The Medical Center of Aurora.
