We hope you had a chance to read the front page of our June Chamber Impact Newsletter last month. Aurora was one of a handful of local communities that required residents to continue with water restrictions. A pretty good visionary decision by our local leaders, as we saw June record some of the hottest temperatures in history.

E-470 marks 15th anniversary with continued success and confidence in the future of the highway

Dillard's grand opening preview

shopping event benefits Ronald

On June 1, E-470 will celebrate its 15th anniversary since the first segment of the highway opened

The financial success and stability of E-470 is well known to the residents of the Denver metro area, but when the highway opened on June 1, 1991, it had its fair share of doubters and naysayers. Some called it the "road to nowhere" and others believed it was destined to fail.

After 15 years of operation, E-470 is a proven financial success and a valuable asset to the metro

When E-470 opened it was only 5.3 miles long and stretched from C-470 to Parker Road in Douglas County and averaged just over 100,000 toll transactions per month. Today, in its fourth year of operation since the final segment of the 47-mile highway was completed on January 3, 2003, E-470 continues to see an increasing number of drivers.

In recent months, E-470 has averaged approximately 160,000 toll transactions on a single weekday. Last year, E-470 saw a record total of 51.5 million toll transactions and recorded toll revenues of \$77.8 million.

E-470 has not only served as an alternative to crowded highways, but it has also been a catalyst for residential and commercial growth.

"Since it first opened, the E-470 corridor has been the focal point for thoughtful, well-planned $\,$

commercial and residential development," said Lynn Myers, Arapahoe County Commissioner and Chairperson of the E-470 Public Highway Authority board of directors.

"The growing number of new commercial and residential developments currently under construction will help define the future success of the highway."

Notable developments along the highway include: the Meridian International Business
Center in Douglas County, the Southlands mixeduse development in Aurora, and the Prairie Center mixed-use development in Brighton.

E-470 has also been recognized as an innovator among toll roads across the nation. It was among the first tollways in the nation to offer non-stop, open-road toll payment via Electronic Toll Collection (ETC) transponders. These same transponders are now in use on the Northwest Parkway and will be used on the CDOT tolled Express Lanes on I-25 beginning in June.

"The road to success and financial stability has not always been easy," said Ed DeLozier, executive director of the **E-470 Public Highway Authority**.

EXpressToll® converting to replaceable battery transponders

Transponders will be phased-in as new and replacement transponders are issued

In response to customer demand, the EXpressToll customer service center will begin issuing replaceable-battery transponders. Early in June, new EXpressToll customers and current customers requesting additional transponders will receive the new replaceable battery

In August 2005, E-470 conducted a survey of EXpressToll customers and 62 percent said they preferred a replaceable-battery transponder over the existing transponder which needs to be replaced when the battery dies.

The new transponder is manufactured by Sirit, Inc. and has a coin-cell battery that can be replaced by the user. The battery can be purchased at retail electronics stores or through the EXpressToll service center.

"We are very pleased that Sirit was able to respond so quickly to the needs of our customers and is now offering a transponder with an extended life period, reducing the transponder's whole life cost," said Ed DeLozier, Executive Director of the **E-470 Public Highway Authority**.

Over 70 percent of E-470's tolls are paid via EXpressToll. Currently, there are over 205,000 customers with EXpressToll accounts and over 381,000 transponders issued.

The EXpressToll transponders are used to collect tolls on E-470, the Northwest Parkway and the new tolled Express Lanes on I-25.

E-470 is a tollway that runs along the eastern perimeter of the Denver metropolitan area. The 70-mph highway extends 47 miles from State Highway C-470 at I-25 in Douglas County, terminating at I-25 near 160th Ave., in Thornton.

IDTOMA-TIC Art Show Scheduled

Idioma-tic explores art and language through multi media artworks by Denver luminaries, Roland Bernier, Andy Miller, Preston Poe and Joseph Farbrook. Bernier's works are included in numerous museum and gallery exhibitions nationally and internationally.

Preston Poe's site specific sound installation "hush" is a playful composition of common sounds crossing cultural boundaries. He received an MFA in multimedia, sound and video from the University of South Florida in 2004. His multi-media installations and videos, often social or political in nature, have appeared in Florida and Colorado.

Joseph Farbrooks' series "Image-text" includes words that stream rapidly while "Facial Arrangements" consist of grids from facial elements moving as if they are talking. Farbrook received an MFA in Media Arts from the University of Colorado in Boulder in 2004 and currently teaches Digital Art at the University of Colorado in Denver. He has participated in film festivals and exhibitions nationally and internationally.

Andy Miller creates visual art for people who can't see by using braille as an abstraction in many of his works. His large wall sculptures include neon, animal hair, metal, and pearls arranged to signify a message in braille such as "When Does Something Qualify as Being Alive?" Miller received his BFA from the University of Colorado in Denver in 1997, and has exhibited locally since 1995.
