## Chamber finds little to love in Employee Free Choice Act

The Aurora Chamber of Commerce is working with the U.S. Chamber of Commerce to closely examine the merits and implications of the so called Employee Free Choice Act (EFCA) legislation pending before Congress.

"We think the legislation as currently written would curtail the rights of both employees and employers and would hamper economic recovery and growth," said Kevin Hougen, Chamber President and CEO. "As an organization representing hundreds of businesses from across the eastern metro area, we are encouraging our membership to oppose EFCA".

Hougen said he felt the EFCA would effectively eliminate the secret ballot election for union organizing. "That would force workers to make the important decision about whether or not to unionize in front of union organizers,

during a stealth campaign," Hougen continued, "and that is of great concern to many of our members." Hougen said Colorado made the right choice when it chose to continue under the Labor Peace

Act. "I think the cooler heads in Colorado understood that businesses and labor unions both could work well under this great umbrella that has covered our relations for more than 65 years."

According to the U.S. Chamber, the EFCU would force workers to make the important decision about whether or not to unionize. "That would invite intimidation and coercion; lead to widespread disenfranchisement of workers who may oppose unionization by cutting them out of the process; and limit an employer's ability to counter false and misleading rhetoric," the U.S. Chamber said in a letter to Congress.



They also pointed out that the EFCA could radically alter collective bargaining by allowing unions to end good faith negotiations and force employers into binding interest arbitration to set all the terms and conditions of a union contract, not just wages and benefits, but work rules, management rights clauses, and how union dues are collected.

Hougen said the Government Affairs and Education Committee has studied the legislation closely and was expected to again recommend to the Board of Directors that they again oppose the legislation as they have in the past. "Given these difficult times, it is more critical than ever that businesses have the flexibility necessary to meet the needs of a challenging economy if we are to create an environment in which businesses can grow and create jobs," Hougen stated. "I just don't think the EFCA is consistent with this critical goal and for these reasons, we respectfully urge you to oppose EFCA."

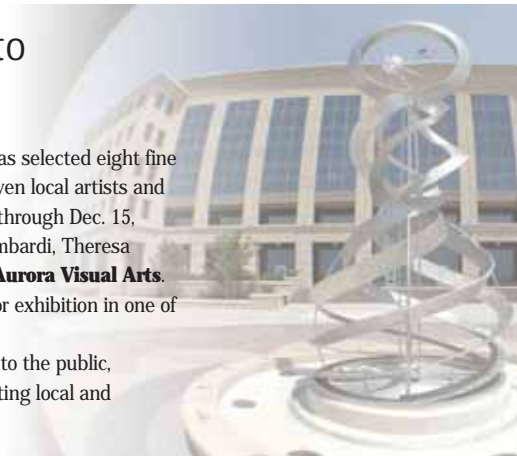
