Building a vibrant, globally-competitive local economy requires that we build bridges across political, socio-economic, and geographic boundaries in our region. Not only is our economic recruitment of growing businesses at risk, but the retention of major employers in the State will be hurt. The union vs. business battle continues to heat up. Early in April of this year one of the State's largest labor unions (United Food and Commercial Workers Local 7) proposed five new ballot initiatives—all carefully named—to be reviewed and considered for placement on the November ballot. The topics included:

Taxable Value and Taxes of Property, increasing the property taxes of non-residential real property from 29 percent to 34 percent. (#95)

Cost of Living Wage Increase, requiring that all employers provide their employees an annual cost of living wage or salary increase. (#96)

Safe Workplace, allowing an injured employee to pursue action in district court in addition to any rights the employee may have under the workers' compensation system. (Companies would have to purchase another costly insurance policy, we have not found a company that even

writes a insurance policy for this action yet). (#93)

Offshore Subsidies, prohibits the State from providing tax credits or subsidies to corporations or companies with business operations in Colorado that move any of their operations to locations outside the United States. (#94)

Employer Responsibility for Health Insurance, requires every employer that employs 20 or more employees in the State of Colorado to provide major medical health care coverage to all its employees and their dependents. (#92)

Union representative have admitted that the above mentioned measures were filed in response to a business-backed Right-to-Work initiative, which would prohibit requiring union membership or fees paid to the union as a condition of employment. Backers of the Right-to-Work initiative recently filed 133,000 signatures in an effort to get the measure on the November ballot. That initiative, in turn, was filed in response to last year's Governor vetoed HB 1072, which would have changed how unions can organize in Colorado.

Currently businesses work under the Colorado's Labor Peace Act, a 65-year-old series of laws that governs the way unions can organize workers.

Governor Ritter has offered an incentive for supporters of a right-to-work initiative and a group of labor-backed initiatives to remove their measures from the ballot. In an effort

to keep the peace, Ritter has offered to veto any legislation that makes a change to Colorado's existing Labor Peace Act. Negotiations continue behind closed doors, and there is no sign yet whether either of the groups will agree to back off of their initiatives. It certainly appears that the fight is on for this summer and we will be watching it closely here at The Chamber. It is a conflict that is sure to have serious implications for those of us in the Eastern Metro business community.
