Legislative committee votes to hire outside professional to handle sexual harassment complaints at Colorado Capitol Colorado Polítics

A Colorado legislative committee has voted unanimously to hire an independent human resources professional to handle workplace harassment complaints - and to do so quickly.

The Executive Committee of the Legislative Council will work with the Office of Legislative Legal Services on creating and posting a request for proposals by Dec. 20, with a submission deadline of Jan. 3.

"I think there's an immediate need and a long-term need and those might not be the same thing," House Majority Leader Rep. KC Becker, D-Boulder, said before the vote. "We might need to meet again, but I think we need to hire someone right now. We need to get someone in pretty soon, figuring out specifics may need adjustment (later on)."

Senate Majority Leader Rep. Chris Holbert, R-Parker, nodded in agreement.

State Rep. Dan Nordberg announces resignation

State Rep. Dan Nordberg, R-Colorado Springs, has announced he will resign his position in January to work for the Trump administration. Nordberg will be the regional administrator for Region 8 of the U.S. Small Business Administration.

Nordberg was first elected to his seat in the Legislature in 2012, and reelected in 2014 and 2016. He represents House District 14, which encompasses northern Colorado Springs and nearby areas. He has long served on the House Business Affairs and Labor committee.

Major Colorado employers plan to pass along some tax savings to workers

Several major companies, following Congress' passage of a tax overhaul that dramatically slashed their taxes, say they will boost employee pay and bonuses in the wake of federal tax law changes.

Corporate America may be getting the message that it had better help generate public support for the Republicans' tax overhaul or risk having it overturned.

Polls show most Americans see the new tax law favoring corporations and the wealthy, even though it's billed as a middle-class tax cut. Some taxpayers are especially concerned about restrictions placed on deductions for state and local income taxes as well as mortgage interest that will likely have many of them pay more in taxes next year.

Colorado's rapid growth sets stage for political war

Colorado's lightning-fast growth is lining up the state for an epic political battle in two short years.

Census figures released Wednesday show the state has the seventh-fastest growth rate in the nation, with a burgeoning population of more than 5.6 million. That's enough babies and newcomers to net the state an eighth congressional district in 2020, prompting a fight over where the lines will be drawn for the new district.

That means the Democrats and the GOP will go to war to protect their incumbents and set boundaries that will swing the new seat into their camp.

Colorado's Gov. Hickenlooper to seek emergency CHP+ funding

Gov. John Hickenlooper, in an effort to keep health insurance going for low-income children and pregnant women, asked for emergency funds for the Children's Health Plan Plus program (CHP+).

Hickenlooper sent his request to the General Assembly's Joint Budget Committee.

"Vulnerable children and pregnant women are being used as bargaining chips," Hickenlooper said in a statement. "This request is not a cure. It's a one-time only band-aid as we wait for Congress to do what's right and secure CHIP funding."

CHP+ is a Colorado program that provides medical and dental care for low-income children and pregnant women whose income is too high to qualify for Medicaid but cannot otherwise afford private health insurance.

Improved state revenue forecast spurs calls for more transportation spending

Transportation-funding advocates ramped up their push for the Colorado Legislature to put more money into roads Wednesday after a state forecast showed that robust economic growth will leave the state with almost \$200 million more in its coffers this year than previously predicted.

The quarterly forecast from Gov. John Hickenlooper's Office of State Planning and Budgeting stated that Colorado is on pace to bring in \$179.2 million more in the fiscal year that ends on June 30 than was predicted even three months ago. It also forecast that the 2018-19 fiscal-year budget, which the Joint Budget Committee is beginning to assemble now, will be \$106.6 million higher than was predicted in September, even though growth will be constrained next year by shortages in the labor market.

Business groups and legislative Republicans have been pushing for more money to be spent on fixing the state's transportation system, which the Colorado Department of Transportation has estimated faces a \$9 billion backlog over the next 10 years. Legislators agreed during the 2017 session to put \$1.9 billion more toward roads and transit through the sale of bond-like certificates of participation, but most transportation advocates have said more needs to be done.

Failing to call 811 before digging in Colorado could cost up to \$75k under gas pipeline safety proposal Denver Post

Responding to growing concerns over gas-pipeline safety, a bipartisan group of legislators is proposing a plan to create a new state commission to investigate and fine those responsible for damages to lines due to digging.

The proposal, which has the backing of Republican state Sen. Ray Scott of Grand Junction and Democratic state Sen. Kerry Donovan of Vail, would impose fines of up to \$75,000 for violations of the state's 811 call system. That system requires excavators to call 811 before they dig. Those calls generate alerts to owners of pipelines who must then identify for the excavator the location of piping and other underground infrastructure.
