

### Cool Water Still a Hot Issue

Our friends in the Aurora Water
Department have pointed out that
the last significant rainfall we
received in Aurora was in early June.
Since then it has been terribly hot
and dry, a condition that has been
responsible for making lawns a bit
crispy and employees glad to be
working in air-conditioned
businesses. The good news is that
Aurora's reservoirs nearly filled with
spring runoff this year. With care

that storage should hold us over through this dry spell. I'm confident Aurora Water customers will continue to conserve water this summer, despite the heat so the picture will not be as grim as it could be.

This weather pattern calls to mind the rationale behind Aurora's Prairie Waters Project. Construction has begun on this project that will provide Aurora with a drought-hardened water supply by late 2010. The project will increase Aurora's water supply by 20 percent or about 3.3 billion gallons annually.

As for dealing with those dry lawns. Melissa Elliott with Aurora Water reminds us that the Kentucky Blue Grass that most of us have is a cool season turf. "When you see brown spots and the green turns that hazy blue color, the turf is doing exactly what it is supposed to do in hot weather," she told us. "Continue to irrigate efficiently and when we get wet weather and cooler temperatures the turf will return to the green that we identify with." ### Aurora Water breaks ground on state-of-the-art purification facility

City of Aurora officials and more than community leaders turned out to help break ground construction of a state-of-the-art purification facility at Aurora Reservoir. The purification facility is a major component of the Prairie Waters Project, Aurora's plan for delivering as much as 3.3 billion gallons of water to the city annually by 2010.

The Prairie Waters Project is a sustainable water supply project designed to ensure Aurora customers receive a high-quality, reliable water supply, said Melissa Elliott, a spokesperson for Aurora Water. "Once complete, it will be one of the most advanced water purification facilities in the country and will to treat up

to 50 million gallons of water per day," she said

The Prairie Waters Project is funded through a combination of tap fees, and water rates

The project had its genesis in 2002 when Colorado experienced a drought so severe the city's reservoirs were drained to just 26 percent of capacity. Aurora's Director of the Water Department, Peter Binney noted that the drought emphasized the need to develop a comprehensive, long-term plan to provide a future supply of high quality, reliable water to the city and began putting together a long-term plan.

The purification facility is a major component of the Prairie Waters Project, Aurora's plan for delivering as much as 3.3 billion gallons of water to the city annually by 2010.

#### Bedwell is tops in his profession

The Association of Public Safety Communications Officials (APCO) recently named Mike Bedwell as Manager of the Year. Bedwell, the City of Aurora's Manager of Public Safety Communications since 2005, was cited for the work he has done in easing some of those pressures felt by those who work in the 911 Call Center. Facing high turnover rates in the stress-filled 911 arena, Bedwell set out to give his team the tools they needed to be successful in their jobs. He focused on bolstering the training provided to his staff. Each newly hired dispatcher completes six months of rigorous training, including a great deal of cross-training across different job functions. A cross-trained staff has allowed Bedwell to decrease the amount of overtime required of the dispatchers and increase their skill-sets. Turnover rates went from 48 percent in 2005 to 18 percent today.

### Aurora water bonds receive credit rating upgrade from Moody's

The City of Aurora water revenue bond credit ratings have been upgraded to an Aa3 (from A1) rating by Moody's Investors Service and affirmed at an AArating by Fitch Ratings according to John Gross, Director of Finance. The high financial ratings will significantly reduce financing and insurance costs for the city's Prairie Waters Project, resulting in an estimated \$2.23 million savings over the life of the \$425 million water bonds.


