Now that I've gotten a couple of months at the helm under my belt, I'd like to share with you my thoughts on a subject that I hear more and more about – one that is near and dear to my profession and myself. I'm talking about the issue of healthcare in Colorado.

Since nearly 60 percent of Coloradoans rely on employer-provided healthcare benefits, I think it only appropriate that the companies who have stepped up should be strongly represented in the growing debate over reform of the state's healthcare system.

Faced with significant annual health-insurance premium increases, some employers—especially small and medium sized companies—are reducing benefits to current and retired workers, eliminating coverage of spouses and dependents and shifting more of the cost to the workers.

Consequently, a growing number of these workers and their families are joining the swelling ranks of the uninsured and seek care in the emergency rooms or under Medicaid. These costs are then shifted to companies and workers with health insurance—and to you and I, the taxpayers.

The Chamber's Mission

The mission of the Aurora Chamber of Commerce is to serve as a voice for the business community, acting as an advocate for its members on issues that affect their growth and long-term economic vitality.

Chair's Letter

Meeting the Healthcare Challenge

Engaging in the debate

In states such as Massachusetts that have undertaken major healthcare policy reform, the business community has been an integral part of the process.

In Colorado, however, the business community has not—in the eyes of many experts, policymakers, philanthropic foundations, healthcare trade organizations and advocacy groups—been adequately engaged in the debate. There have been instances, however, where business leadership has been created around such specific issues such as small-group health insurance reform.

The time has come, in my view, for the statewide business community to participate fully in the discussion that is beginning over how to reform the state's healthcare system to address such major problems as:

- Major annual increases in healthcare insurance premiums;
- Increasing numbers of uninsured and underinsured; and
- Increasing numbers of small-and medium-sized firms that no longer offer healthcare benefits.

Meeting the challenge

Our biggest challenge in my view is to educate and mobilize the business community to engage in this debate in a sustained manner. It is important to understand that the business community, like our Chamber, is not a homogenous entity. It encompasses employers from the very small to the very large across a wide variety of industries statewide. Add to this the fact that the number of major companies headquartered in Colorado

has declined in recent years, resulting in the loss of high-profile business leaders able and willing to speak out on such major public-policy issues as healthcare. A number of competing local business organizations across the state complicates the problem of systematically securing business involvement.

To overcome these barriers, the Aurora Chamber of Commerce proposes an aggressive, focused strategy to successfully engage the broad business community in major healthcare policy reform. We hope to build on some of the proposals laid out for us by the Colorado Association of Commerce and Industry (CACI) at their Business Healthcare Forum back in October. Our goal is to partner with CACI to help identify and direct the business community.

With the state legislature about to open their 2008 session; and with the Governor's Blue Ribbon Panel on Healthcare about to present their proposals, the time is right for us engage in the process to ensure the direction this state goes is in the best interests of the business community as well as the individual when it comes to healthcare. I look forward to hearing your thoughts in this regard.

E-470 opens new 1.4 mile flyover at I-70

Just in time for ski season, northbound E-470 drivers exiting to westbound I-70 at last can now bypass a slalom course of traffic signals at that interchange in order to head to ski areas – or other points west.

E-470’s new 1.4-mile-long, \$18 million flyover opened Oct. 25, creating a seamless connection for the northbound E-470 to westbound I-70 transition.

With completion of the new 7,645-foot ramp, which includes a curved and banked 1,616-foot bridge, motorists now are able to take a direct flyover ramp instead of proceeding through the traffic signals at the existing interchange.

“The new ramp seamlessly connects northbound drivers to westbound I-70 and will further reduce accidents,” said Jo Snell, E-470 manager of marketing and public relations.

“It is the latest stage in a long-term plan to create a fully-directional interchange unimpeded by traffic signals, and is the second flyover added at the interchange in the past 15 months.”

Aurora elects new APS school board members

Three new members of the **Aurora Public Schools** Board of Education were sworn in at the Nov. 13 board meeting. Amy Prince, Mary W. Lewis and Pete Cukale replaced Debbie Barton, Ed Lord and Susan Tabacheck. They join Jeanette Carmany, Matt Cook, Debbie Barton, and Jane Barber. The board addresses the concerns of the local community while working within the framework of state and federal laws. This vast assignment includes approving curriculum and instructional materials and adopting the annual budget.

The seven members of the board are elected at-large by registered voters who reside within the boundaries of the school district. Members serve four-year terms and receive no compensation.

Aurora again selected for Workforce program

2008 brings changes to Workers’ Compensation rules: Are you ready?

When the clock strikes midnight on December 31, more than just the year on your calendar is going to change. Some workers’ compensation rules are also changing and **Pinnacol Assurance** wants you to be prepared.

HB 1176, the Employee Choice of Physician law, requires Colorado employers to designate two medical providers to treat employees who are injured on the job. The two medical providers must be at two distinct locations without common ownership. In some cases, rural employers are exempt from the two-provider rule if there are a limited number of available providers. The law goes into effect on January 1, 2008.

In mid October, **Pinnacol** put in place a number of processes to ensure that its policyholders do not incur fines and penalties due to non-compliance with this new law:

- **A provider designation process** that ensures all policyholders will always have two providers listed on their policy.

- **A robust Web-based provider designation system** that allows for quick and easy provider selection and management.

For policyholders that did not have two designated medical providers, **Pinnacol** has been proactively designating additional providers and sending notification letters with the designation details.

For Aurora Chamber members, **Pinnacol** identified the four SelectNet providers located nearest to the address listed on your policy and added them to your policy. If you had a designated provider(s) listed on your policy, that provider remains on the policy as the preferred provider.
