## Alfred P. Sloan Award Aurora Chamber selected as finalist

Aurora Chamber of Commerce has been selected as a finalist for the 2008 Alfred P. Sloan Awards for Business Excellence in Workplace Flexibility in the greater Aurora area.

To reach this stage, applications were measured against nationally representative data from Families and Work Institute's National Study of Employers and had to score in the

top 20% — at or above the 80th percentile of employers nationally.
