AFRL names winners – including a surprise!

The Aurora Chamber of Commerce's Defense Council held its 38th Annual Armed Forces Recognition Luncheon on June 13, to honor the military serving in the Metro area. The **Colorado Technical University**-sponsored event annually

honors eleven military members representing each of the branches of service and their Reserve and Guard components, as well as one civilian from the community. Also involved the event was **Northrop Grumman** and **Raytheon** as well as 36 other companies who support the military.

This year's speaker was Kelly Sullivan Loughren, the granddaughter of Albert Sullivan, one of the five Sullivan brothers who died while serving together on a Navy ship in World War II. Master of Ceremonies duties were performed by KEZW Radio personality Rick Crandall, an Air Force veteran and founder of the **Colorado Freedom Memorial Foundation**.

The eleven military honorees came from every major unit at Buckley Air Force Base as well as one from 233rd Security Squadron that is based near Greeley. They were selected from more than 40 nominees by a special panel of The Chamber Defense Council.

The surprise of the day was the Bob Cardenas Award, given to Aurora Chamber Vice President George Peck, who has worked tirelessly in

supporting our Armed Forces. "A U.S. Air Force Public Affairs Officer for much of his career, George is actually the reason that AFRL and the Aurora Chamber of Commerce Defense Council are both so successful," the citation continued. "George will be retiring in 2015, and it was certainly fitting to for him to receive the award honoring a person who has made extraordinary contributions to building greater understanding and support of the military in the Metro area."

The luncheon, attended by nearly 600 military and their supporters was held at the Doubletree by Hilton Hotel Denver and organized by Defense Council Vice Chair Suzanne Pitrusu with **Community Banks of Colorado**. "It is our way of recognizing all members of the Armed xForces throughout

How hot is too hot?

A look at today's real estate market

The market is GREAT, right?! On fire! What's that saying, "if you can't handle the heat...?" How great the market is depends on who you're asking. Housing inventory is at

record lows. Prices keep climbing. Multiple offers are the norm. Buyers are feeling the pressure - especially, in the segment of homes priced below \$400,000.

Didn't we peak in 2013? The funny thing about peaks is that you don't know you're there until you're over it. In this moment, we can't be certain. We are four years past the bottom of the market and analysts believe that we will continue to experience a seller's market for the next few years. The market has—and always will—cycle. (See inset for a graph of Denver Metro's 5-Year Home Inventory Trend.)

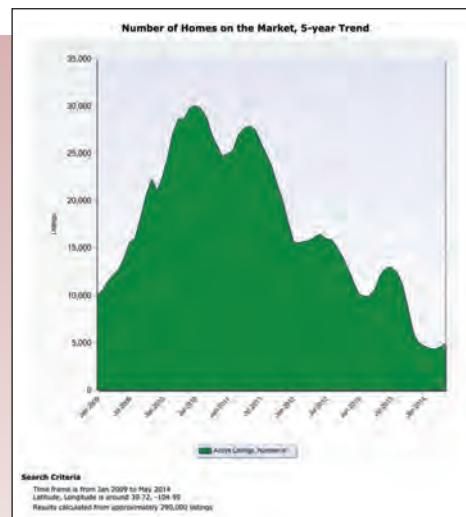
What can be expected in the current market? To compete, buyers must bring their best offers—meaning, offering more than list

price, not asking for extras, and sometimes giving up termination clauses. Even more challenging is when a buyer has a home they need to sell, in order to purchase the new home. An offer without a conditional sale of another property is much more attractive to a seller. This is giving first-time homebuyers an advantage over move-up buyers.

On the flip side, sellers must be cautious of overinflating their home's value. With buyers offering significantly over asking price to get their offers accepted, sellers can get caught up in the *cha-ching*. They risk the home not appraising and causing problems with the transaction 2-3 weeks into the process.

A vicious cycle: An emerging side effect of the market is that would-be sellers are hesitant to put their homes up for sale, for fear of jumping into the pool of buyers currently competing for their next home. Thereby, keeping inventory low...and so the market continues.

So, what are sellers to do? The best option for sellers is to sell their current home, find a

Greater Metro Denver Healthcare Partnership Update

The Greater Metro Denver Healthcare Partnership (Partnership) is an industry-led, workforce, education and economic development collaborative designed to meet the hiring, retention, and training needs identified by six of the largest hospital systems and ambulatory care facilities in the Greater Metro Denver area. The Partnership provides direction and solutions to meet the healthcare industry's workforce needs.

The Partnership includes three workforce regions, key post-secondary educators and virtually all the major hospitals and ambulatory care systems in the Metro Denver region. The Partnership has focused on four in-demand and difficult-to-fill occupations, and based on that success, has now added five additional critical occupations to the project. Because of its success, the Partnership has been sustained beyond the initial grant period (July 1, 2011 - June 30, 2013) and continues to identify diverse sources of funding.

Results produced through December 2013 include:

- Number served: 153

- 97 new enrollees
- 79 of the 97 new enrollees have completed training. Of these, 70 have obtained employment (89 percent)
- 56 incumbent workers from eleven partner facilities
- Impact to-date is measured based on the difference in pre- and post-training earnings for three of the targeted occupations (Medical Laboratory Scientist, Medical Laboratory Technician, and Bachelor of Science in Nursing)
- Aggregate difference in earnings is over \$1.6 million
- Total cost for training was \$345,772
- Cost/benefit ratio was 4.72
- In addition, training 50 experienced healthcare professionals as Clinical Scholars significantly increased the experiential portion of the region's healthcare training pipeline.

One partner healthcare institution indicated that they were able to increase their new BSN placement capacity by 36 percent.

Overall, the Partnership has exceeded all of its initial goals and is now focusing on new targeted occupations as the project moves forward.
