LeGare proposes bond extension for infrastructure

City Council member at large Bob LeGare has an idea that would bring many badly needed improvements to Aurora and Eastern Metro roads at no additional cost to already hard-pressed taxpayers in the area. He rolled the idea out at the Chamber Transportation Committee on April 4.

LeGare has formally proposed to the Aurora City Council that a mill levy that helped finance the Alameda Exchange be continued and applied to several critical infrastructure upgrades. "There would be no additional taxes imposed on our citizens," LeGare said, "but by continuing the small amount people are already paying, we could greatly improve our local roads."

LeGare, who strongly believes in full transparency when it comes to City

spending, said the continuation would be targeted at specific projects and not be used for the general fund.

Some of the projects that would be covered include better access to Buckley AFB by extending Sixth Avenue out to an E-470 exchange, and pushing Tower Road through from 6th Avenue to Colfax.

In addition, LeGare has proposed several access improvements for the rapidly growing Anschutz/Fitzsimons Campus, as well as upgraded roads in the Southeast Aurora area, which include the widening of Arapahoe Road between Waco and Himalaya (with additional support from Centennial and Arapahoe County), and the partial widening of Gun Club Road including an upgraded Quincy/Gun Club/E-470 interchange.

Nearly two dozen other projects, somewhat smaller in scope, are also proposed all over the city, such as improved parking for the new Liff Light Rail station, sidewalk and bike path improvements throughout the city, and badly needed changes to the Parker corridor around Quincy.

The Chamber Transportation Council, led by Chris Fasching with Felsburg Holt & Ullevig, voted unanimously to support the initiative and put the proposal before the Chamber Board for their approval. "Many of Councilman LeGare's proposals are in synch with the projects our committee has been proposing for more than six years now," Fasching said. "It is great to see some movement in that arena."

The Eastern Metro Area is very well situated for strong, sustainable growth.

It's been an honor representing the entire Chamber membership this year on the Board of Directors. I'd especially like to single out Kevin and his remarkable staff: George, Naomi, Linda, Paul, Kimberly, Mitzi and Mary Beth. They truly define the word synergy: their total output is considerably greater than what you might expect from the sum of this great group. And to the many volunteers that give the Chamber that extra touch upon which our reputation has been built—thank you. My hope is that we will continue to work together to make the next 110 years as fruitful as this year has been for us all! Thank you again for all of your support and dedication to our cause.

Leadership Aurora applications due July 15

The Chamber is currently accepting applications through July 15, 2012 for the 2012-13 Leadership Aurora class. Freedom Memorial has new site, renewed campaign

The yet-to-be-built Colorado Freedom Memorial has a new home, according to Rick Crandall, president of the Colorado Freedom Memorial Foundation.

“The City of Aurora has long been a partner of this project,” Crandall said, “and has now created an incredible space for the Memorial in the new Springhill Park adjacent to the Beck Recreation Center.”

The park, originally sited south of Buckley in an undeveloped city park area, is now located directly north of Buckley Air Force Base with four acres set aside for the Memorial, gardens and gathering spaces. “This will be the perfect place for families and comrades of those who sacrificed their lives in service to come and remember,” Crandall stated.

Crandall also announced a new fund-raising campaign to complete the project. He is teaming up



with The Chamber, VisitAurora, KEZW AM-1430 Radio, Dry Dock Brewing Company, and the American Legion in Colorado to raise the final \$400,000 to allow construction to begin this year.

Crandall urged companies throughout the metro area to get involved in the drive. “Challenge your

employees to get involved by coming up with their own fund raisers,” he suggested.

On May 25, KEZW Radio will be hosting a 12-hour radio-thon at the Dry Dock Brewing Company in Aurora from 6 a.m. until 6 p.m. “We’ll be asking everyone along the Front Range to put us over the top by contributing to our FREEDOM 2012 drive,” Crandall said.

Rural/Metro-Pridemark checks stress levels at State Capitol

On March 12, **Rural/Metro-Pridemark Ambulance** employees checked the blood pressures (BPs) of State lawmakers and staff to identify whether the House or Senate is "more stressed." According to the results of this unscientific, informal survey the House has a higher average BP, making it more "stressed" than the Senate.

Sixteen House Representatives and staff participated in the BP checks, with an average BP of 140/85. Seven State Senators and staff participated, with an average of 139/83. A normal BP is a systolic (top number) between 100 and 130, and a Diastolic (bottom number) between 65 and 85.

Rural/Metro-Pridemark Ambulance organized the event to bring greater awareness to the pre-hospital services provided by ambulance first responders, including paramedics, emergency medical technicians (EMTs) and registered nurses. Legislators and staff also had the opportunity to talk with first responders, and to view emergency medical equipment.
