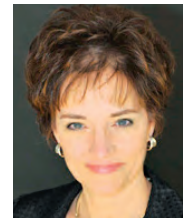
implementing the modernization of the air traffic control and national airspace. Pierce is the environmental and community representative on the NAC.

The royalties from this project will be given to St. Jude Children's Hospital. The book is tentatively scheduled for release in late 2014.

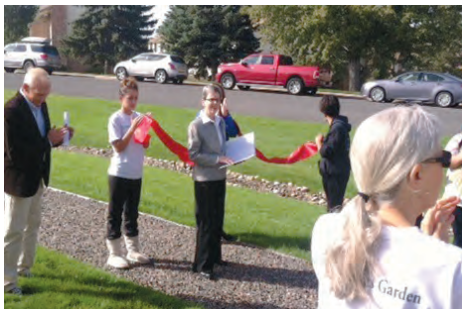


Pumpkins for the kids from May Farms

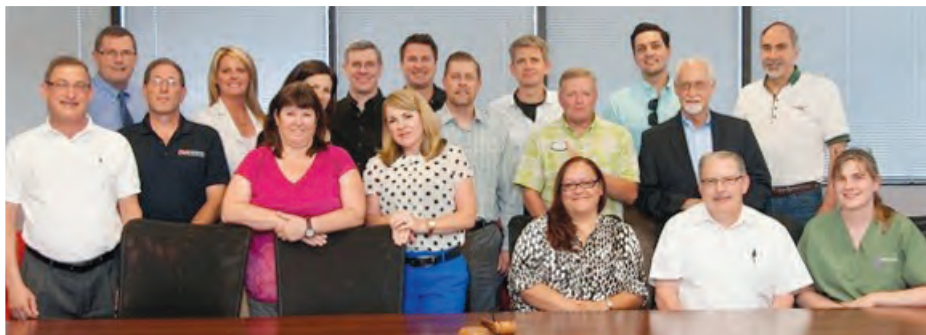
