As we reflect on The Chamber's past year in an effort to glean the lessons of experience, it is important to commend the challenges met, regret the opportunities missed, and consider the direction we should take for the future. One constant, however, is that we have an outstanding organization of diverse business interests, who come together regularly with a single purpose -to enhance the atmosphere and health of our communities. Just a few highlights of this past year:

- **Transportation Committee**; work begins on **eight Transit Oriented Development (TOD)** sites, along with the opening of the new I-225 and 17th Place interchange.

The Colorado Community College System comprises the state's largest system of higher education serving more than 159,000 students annually. It oversees career and academic programs in the 13 state community colleges and career and technical programs in more than 160 school districts and six other post-secondary institutions. ■

And, especially if one of your goals is to be healthier or reduce cancer risk, stress is important to manage! Though stress doesn't have a direct link to your risk of developing cancer, it can lead to unhealthy habits, like smoking or overeating, which does increase

your risk. So, find a support group — whether that's friends and family, a professional psychologist, or someone else — and make sure to keep them updated on your progress.

Be gentle with yourself

Don't beat yourself up about mistakes or mishaps. Everyone has setbacks when it comes to goals and resolutions, so you're not alone. But beating yourself up about every little misstep is just going to make it harder to get back on the wagon. Like eating for cancer prevention, it's the overall pattern that matters, not individual foods or meals.

When you do make a mistake, reflect on why it happened, what you can learn from it, and move on. Everyone has bad days, and it's okay — as long as you get back in the saddle when you can.
