Chair's Letter

This year is already flying by, and it's hard to believe that eight dynamic months have gone by since I've had the pleasure of serving as the Chair of the Aurora Chamber of Commerce. We started the year out with the question of "why" chambers exist and what value we bring to members and non-members.

The question remains consistent and can be evaluated by the 3Cs:

- 1) The Chamber is a **Catalyst** for business growth;

The '3cs' and the Economic Impact our Chamber has, was evident as a **Convener** at the Association of Defense Communities summit we attended in San Diego the week of Feb. 12-14. Our team representing Buckley Air Force Base, the City of Aurora, and The Chamber of Commerce was selected to participate with senior experts on key issues facing our communities. We had a panel of experts speak on the funding we have received (\$26 million dollars to date) from our Readiness & Environmental Protection and Integration (REPI) efforts to expand and protect Buckley AFB from encroachment.

The Department of Defense is responsible for about 8 percent of the state's total economy in terms of employment, earnings, and state tax revenues. BUSINESS FOR THE ARTS

Touring the Possibilities at the Colorado Film School

Tuesday, January 9, 2018

The Colorado Film School is housed in an unassuming building on the Lowry campus of the Community College of Aurora. However, once inside and walking around, the possibilities seem to be endless – as witnessed by a group of Chamber members attending the January 9 Business for the Arts tour of the school.

Brian Steward, director of The Colorado Film School, began the tour in the theatre, with a briefing about the curriculum and a viewing of student work for commercials, through a partnership with Toyota.

The Film School currently offers 48 credit Certificates and 75 credit Associate of Applied Science Degrees in Acting/Directing, Writing/Directing, Writing/Producing, Screenwriting, Cinematography, and Post Production. All first semester students are required to take courses in Production I, Post Production I, and Short Script Analysis, and all students are required to take an acting class – in order to understand film from the other side of the camera. Steward is proud of their ‘Safe Acting’ course, taught by Galina Boulgakova, as it’s important for actors to be able to disengage from difficult roles.

With a tri-fold mission of training students for careers in the film and video industries, serving as a catalyst for local film and video production, and serving as an industry-wide resource for research and development in production, CFS faculty ensure that graduating students are prepared for their next step, whether that’s working or more education in the field. CFS also hosts summer camp sessions for Downtown Aurora Visual Arts (DAVA) youth, as well as local high school students.

“It’s all about telling stories through metaphors and through film – and it’s a lot more

work than most people can imagine,” said Steward. “But our students and faculty are dedicated to their craft, to working together, and to creating incredible film products.”

When asked about the future of the School, Steward shared that he would like to be able to offer a four-year degree, but admitted that that would certainly require expanded facilities, faculty, and funding. “It’s good to dream, and we will keep that dream in mind – and we even have a plan for a four-year program, but for now we will continue to provide two and three year degrees that are educating incredible filmmakers and citizens of the world.”

CCA Arts and Communication: Inspiration and Perseverance Thrive Tuesday, February 6, 2018

The Arts and Communication Department at Community College of Aurora is another hidden gem of educational opportunity in the community, and on February 6, 2018, a large group of Chamber ‘arts enthusiasts’ were treated to breakfast and a broad overview of what’s happening within the walls of CCA’s Arts Building on the CentreTech Campus.

Offering degrees and certificates in Art, Communication, Music, Theatre, and Humanities, CCA’s Arts and Communication Department is busy, productive, and innovative – and the faculty and staff are engaging and engaged.

The well-choreographed presentation included Lynette Jachowicz, PhD, Chair of Arts and Communication; Kate O’Donnell, Lead Art Faculty; Jonah Skurky-Thomas, Art Faculty; Vicki Graham, Lead Communication Faculty; Stacy D-Angelo, Director of Theatre; and Michael Pickering, Director of Music.

Pickering walked attendees through what he titled the “Long Strange Trip It’s Been,” which refers to the academic process required to create and receive approval for a new program within the department. Pickering began with a vision for a Music and Entertainment Entrepreneurship Program in 2016, and is planning to roll the program out fall 2018.

His sound advice to all during such any long and complicated process is “If you want to go fast, go alone. If you want to go far, go together.”

Dr. Jachowicz shared that the department is also interested in exploring engaging with the community through bringing in local artists to

inspire and teach students, as well as finding internships for students with local businesses.

TRANSPORTATION

Better Transportation, Better Colorado: DRCOG and Legislative Updates Wednesday, February 7, 2018

With continued economic growth and the growing population, Transportation has become a hot topic in Colorado. Granted that all of the other issues, including healthcare, housing, jobs, etc. are also of great importance – but how do we ‘get to’ all of these other priorities? Transportation.

At the February 7, 2018 Transportation meeting, attendees were updated on the broad reaching transportation-related efforts and issues facing Denver Regional Council of Governments (DRCOG) and The Colorado Legislature in 2018.

DRCOG representatives Celeste Stragand, Regional TDM Program and Marketing

Manager, and Steve Cook, Transportation Planning and Operations, gave a comprehensive overview of *Way to Go*, the 2045 Regional Transportation Plan, Transportation Improvement Plan, and other activities.

Stragand, who manages the *Way to Go* program, talked about how the program works across the region as a partnership between DRCOG and seven transportation management associations in the region. Goals of *Way to Go* include reducing traffic congestion, improving air quality, and reducing single-occupant vehicle trips and vehicle miles traveled by 10 percent each by 2040.

Specific to Aurora, Cook noted recent DRCOG funded projects, including the 23rd Ave. Bicycle/Pedestrian Path, the Metro Center connection facilities, and Colfax Ave. bicycle/pedestrian project. In addition, Toll Gate Creek Trail and the Westerly Creek Connection are in progress. DRCOG continues to explore emerging transportation trends and initiatives such as Mobility Choice Blueprint, CDOT’s Road-X, autonomous vehicles, connected vehicles, ride hailing companies, package delivery methods, and improved human service transportation.

“Money to support all types of projects is always an issue,” said Cook. “But we continue to move forward and to best leverage the dollars we have and those we anticipate.”

Regarding Transportation issues in the Colorado State Legislature, Axiom Politics Legislative Director Melissa Nelson-Osse, and Legislative Advocate Michael Steppat talked about current and potential transportation bills.

Legislators' Breakfast

Monday, January 9, 2018

The annual pre-session Legislators' breakfast was held January 9 at the Community College of Aurora. The event hosted more than 100 attendees to meet and learn more about the Eastern Metro Legislators. Government Affairs committee chair, Su Ryden, former House Representative and small business owner, began by introducing Mayor of Aurora, Steve Hogan and newly-elected Mayor of Centennial, Stephanie Piko.

Ryden then introduced present Senators and House Representatives, who each had an opportunity to speak about their plans for the upcoming session. Legislators giving updates were: Senator Nancy Todd, SD28; Senator Rhonda Fields, SD29; Representative Mike Weissman, HD36; Representative Jovan Melton, HD41; Representative Dominique Jackson, HD42; and Representative Phillip Covarrubias, HD56. Top priorities discussed were transportation, healthcare and safety, along with other pressing issues such as veterans' affairs, economic development, taxes, and labor and employment.

Legislators who were invited but could not be present are: Senator Dominick Moreno, SD21; Senator Kevin Priola, SD25; Senator Daniel Kagan, SD26; Senator Jack Tate, SD27; Senator Lois Clark, SD31; Representative Dafna Michaelson-Jenet, HD30; Representative Joe Salazar, HD31; Representative Andrienne Benavidez, HD32; Representative Cole Wist, HD37; Representative Polly Lawrence, HD39; and Representative Janet Buckner, HD40.

And the Session has begun: Legislative Updates

Thursdays, January 18, February 1 and 15, 2018

Throughout the legislative session, the Government Affairs, Education, and Energy committee meets twice a month on the first and

third Thursdays, to keep the committee informed as new bills are frequently being introduced.

The Eastern Metro Legislators are invited to attend and provide updates on issues they are supporting. Representatives from Axiom Politics, the Chamber's Lobbyist, also attends meetings, providing information and updates on existing bills and their current positions at the Capitol.

The committee is often advised by Axiom Politics, and will sometimes take positions on bills if there has been a motion to support or oppose. The committee will then bring their position to The Chamber's Board of Directors, to make the final vote.

To date, the committee has taken a position on three bills:

- HB 1001 - OPPOSE - FAMLI Family Medical Leave Insurance Program
- HB 1033 - SUPPORT - Employee Leave to Participate in Elections
- HB 1178 - OPPOSE - Hold Colorado Governments Accountable Sanctuary Jurisdictions

The committee has also discussed and are monitoring the following bills:

- HB 1034 Career and Tech Education Grant Program

One topic of discussion was 'workplace

policies,' and the perception of what a healthy policy means. Many people think of a policy as something they are

required to do, and therefore it is not always met with a welcoming attitude. The group discussed that a healthy workplace policy is more about the workplaces' culture and how a policy might also be called "guidelines," to soften the impact, perception, and to gain better acceptance within the organization.

Jennifer Tellis, Worksite Wellness Specialist with Tri-County Health Department, and Coalition liaison to The Chamber also opened the conversation for attendees to share their ideas about how to creatively use funding provided by the grant. Some innovative ideas include massages, healthy food for meetings, purchasing plants for the workplace, a bring your dog to work day, and an aromatherapy room or white noise machines for loud work areas.

It was a lively discussion, interrupted only by a few stretch breaks and some laughter - which are both incredibly healthy.

Workplace Health Symposium Wednesday, February 14, 2018

In place of the February Work Well 2.0 Health Series meeting, coalition and Chamber members were invited to attend the American Heart Association's Workplace Health Symposium at the University of Denver Cable Center.

The Symposium featured keynote speaker Kyra Bobinet, MD, MPH, CEO of EngagedIN, a neuroscience-based design firm specialized in behavior change - who spoke about what truly drives employees to connect with their own well-being. "Because, you know, people don't always do what they know they should," states Dr. Bobinet.

DIVERSITY AND INCLUSION COUNCIL / WOMEN IN BUSINESS

"You Don't Belong:" The Tacit Messaging of Gender Micro-Inequities in the Workplace

Friday, January 12, 2018

The Diversity and Inclusion Council and the Women In Business Committee partnered in January 2018 to host Maria "Giugi" Carminati, JD, with Carminati Law PLLC: The Woman's Lawyer, who presented on the topic of "You Don't Belong: The Tacit Messaging of Gender Micro-Inequities in the Workplace."

Giugi began by sharing her background in the industry and how she came to be The Women's Lawyer. Throughout the presentation she offered facts to support her data and story. Some examples are:

- Women make up approximately half of all law school enrollees (48.7 percent) and J.D.'s (47.3 percent), respectively. However, women make up:
 - o Less than 25 percent of all private firm partners,
 - o 18 percent of equity partners, and
 - o 18 percent of managing partners for the 200 largest firms in the U.S.
- In corporate law, women make up 24.8 percent of general counsel for Fortune 500 corporations

Giugi related these facts to her personal story, explaining why she decided to start her own practice. She also discussed micro-aggressions against women and how this has — and can — affect women in the workplace, in any field.

- Chester Pierce, MD, a Harvard Medical School psychiatry professor, first coined the term micro-aggressions in the 1970s, defining them as "brief and often subtle everyday events that denigrate individuals because they're members of particular groups."
- Micro-aggressions differ from ordinary aggressive acts in that they do not necessarily intend harm.
- Micro-aggressions are often subtle and can take on both verbal and nonverbal formats.
- Micro-aggressions have been utilized to explain subtle sexism and sex-based discrimination against women
- Several studies have shown that gendered micro-aggressions cause detrimental consequences to women's psychological and behavioral health as well as their careers

Giugi offered some vocabulary that many can relate to, including men who were present (as they laughed and nodded in agreement):

- **Intrusive Interrupting:** intentionally or unintentionally usurping the speaker's turn at talk with the intent of ceasing the speaker's ability to finish organically
- **Mansplaining:** a man interrupting a woman to explain to her something that she actually knows more about than he does
- **Maninterrupting:** unnecessary interruption of a woman by a man
- **Bropropriating:** a man taking a woman's idea and taking credit for it

In her final thoughts, she gave advice on being proactive and how to acknowledge that gender bias is happening in the workplace:

- Be aware
- Recognize the existence of unconscious biases
- Counteract internalized sexism (trainings, seminars)
- Practice bystander intervention
- Credit work where credit is due

Inclusion Drives Innovation: Bridging Business and Ability Friday, February 9, 2018

In a discussion about diversity, the topics of race, ethnicity, gender, and sexual orientation frequently come up, but it's important to not forget all the characteristics that create a persons' self being.

Jeff Sidders, MD, business outreach specialist with the Colorado Department of Labor and Employment, Division of Vocational Rehabilitation, discussed the importance of capability in his presentation to the Diversity and Inclusion Council on February 9.

Dr. Sidders shared a bit about his personal background and how a brain tumor changed his life from practicing medicine, to becoming an advocate at the Department of Labor and Employment. He discussed how life can shift unexpectedly, and suddenly what a person used to be able to do, is no longer possible.

In his presentation *Inclusion Drives Innovation: Bridging Business & Ability*, he said "Diversity and Inclusion are good for the bottom line and absolutely necessary to remain relevant in today's increasingly interconnected markets and global economy." Dr. Sidders refers to the term **Differently-Abled:** a physical or mental condition that interferes with a person's ability to walk, talk, see, hear, learn, speak, etc. He brings this up to make his point that disability is **NOT** a **handicap**. A handicap is the barrier. The example he gives is "stairs are the **handicap**. A person's **disability** might be the inability to climb stairs."

To be inclusive in a workplace, it is important to know these differences. He also acknowledges that disability affects people of all ages, race, gender, and backgrounds, and that nearly 20 percent of 54 million people in the U.S. have a disability. That's approximately 1 in 5 individuals, in which many of these individual's disabilities are hidden and not readily apparent. The likelihood of acquiring a disability increases with age. "This is the one minority group that any one of us can join at any time."

Dr. Sidders provided some best practices on how to be inclusive in the workplace with differently-abled employees such as:

- Assist with recruiting
- Determine reasonable accommodations and assistive technology needs
- Promote a positive and barrier-free workplace
- Provide disability awareness training

productivity and that a diverse and inclusive workforce is critical to success. Dr. Sidders concluded with a statement to encourage employers, "you now know a virtually untapped source of pre-screened qualified candidates."

That Phone Conversation Isn't Going Anywhere, But Your Car Is

Have you ever arrived at your destination with no recollection of the trip, missed an off-ramp exit, or not see the brake lights in front of you? These are a form of distracted driving called inattention blindness.

Drivers using cell phones look at, but fail to see up to 50 percent of the information in their driving environment. They do not process everything in order to effectively monitor their surroundings, identify potential hazards, and react to unexpected situations. The danger of inattention blindness is that when a driver fails to notice certain events, it's impossible to perform a safe response such as braking or maneuvering the steering wheel to avoid a crash. Just the act of using a cell phone while driving, even hands-free, increases your crash

risk by 4 times.

In 2015, Colorado saw a minimum of 40 distracted-driving crashes every day. From 2014 to 2016 the percentage of Americans who owned a cell phone rose from 75 to 81 percent. Therefore, your chances of interacting with a distracted driver each time you get behind the wheel is significant.

What can you do? Make a pledge to keep your eyes on the road, your hands on the wheel, and your mind on driving:

- Put your cell phone in the glove compartment while driving
- Install an app on your phone that tells callers you are driving and will text or call back when you have arrived at your destination



- Place your device in a cell phone slip that deactivates your phone while driving
- Be a positive role model for your children who watch your driving behaviors every time they get in the car with you


