Report Finds Colorado's Defense Sector Produces \$36.6 Billion Economic Impact

A recently completed statewide economic study shows that Department of Defense (DoD) and corresponding activities produce a \$36.6 billion economic impact on Colorado's economy. These results are much higher and farther reaching than initially understood and represent over 7 percent of the state's total economy in terms of employment, earnings, and state tax revenues.

The data shows that the state's defense sector is a significant economic driver along the front range, and most importantly, in smaller counties across the state. Local employment, incomes, sales and tax revenues are all enhanced by DoD activities, especially when factoring income from military retiree and veteran pensions and compensation.

"We are extremely fortunate to live in a state where the economic benefit from the defense-related sector is so significant. We also admire and appreciate the men and women who serve and have served, and how much they contribute every day to strengthening and enriching our

communities," said President and CEO of The Aurora Chamber of Commerce, Kevin Hougen.

Colorado is revolutionizing the defense and aerospace industry with more than 400 companies who are leading and supporting groundbreaking missions, a variety of military commands, cutting-edge space exploration programs and renowned research laboratories and universities.

The report, performed by Summit Economics LLC., and commissioned by the Colorado Springs Chamber & EDC and Military Affairs Council, Aurora Chamber of Commerce and Defense Council, and PuebloPlex, updates the economic aspects of a 2015 study authorized and funded by the Colorado Legislature and administered by the Colorado Department of Military and Veterans Affairs. This updated report

adds the economic and fiscal impacts of Military Retirees, Veterans, and the Veterans Administration's (VA) expenditures in Colorado. ■

We are at a reception in Anchorage, Alaska, and touring NORAD's aerospace warning mission with its headquarters located at Elmendorf Air Force Base, Alaska. For more than 60 years, we have had this remarkable partnership that provides an integrated tactical warning and attack assessment to the governments of Canada, Mexico, United States,

Puerto Rico, and the Bahamas. NORAD is our homeland defense; there is no obligation more sacred than defending the homeland. It is the number one priority and no-fail mission of our countries.

Another poignant development that you may have heard about is the announcement that **Front Range Airport** has become the newest **Air and Space Port** in the Country. On August 17, the Federal Aviation Administration granted **Adams County** a spaceport site operator license at Front Range Airport. The Colorado Air and Space Port will serve as America's hub for commercial space transportation, research, and development. Horizontal launch facilities like this are developing around the world and have the potential to become the foundation for a global suborbital transportation network. What comes with this new opportunity is research and development, future manufacturing, and pilot and flight training. ■

TRANSPORTATION

Wednesday, August 1, 2018
Update about E-470 Highway Authority

E-470 is a 47-mile, all-electronic toll road that can take travelers through eight jurisdictions. This user-financed toll road currently accommodates 31,300 vehicles per day, with an estimated 56,300 per day by 2040.

The Executive Director of the E-470 Public Highway Authority brought Transportation committee members up-to-date on E-470 traffic trends, how toll revenues are used, recent initiatives including the Stephen D. Hogan Parkway extension and freezing Express Toll rates, multi-use trail connections, the Quincy

ramp relocation, and the road widening of Quincy to I-70. The presentation was followed by a tour of the state-of-the-art facility.

GOVERNMENT AFFAIRS, EDUCATION, AND ENERGY

Thursday, July 5, 2018
Tour of Terrapin Care Station



The Government Affairs, Education and Energy committee took a field trip to Terrapin Care Station Cultivation Facility and Dispensary, located at 11900 E. 33rd Ave., Aurora, CO 80010, for an educational tour of the industry. Shawn Coleman, director of government affairs for Terrapin Care Station greeted the 22 attendees and gave an overview of what they would see on the tour.

The Terrapin staff explained the entire process of plant cultivation, and attendees were allowed to touch, smell, and take pictures of the plants. Questions were asked about extraction and how THC is transformed into oils, edibles, and products called sugar, wax, and shatter. They also shared information about health codes, tracking of product, and federal laws.

Thursday, August 2, 2018
Sales Tax for Transportation and an Overview of the State Budget

The Government Affairs, Education and Energy committee hosted President of MOVE Colorado Carla Perez, and Deputy Director Jason Schrock with the Governor's Office of State Planning and Budgeting, for two informational presentations.

Perez gave an update on the Let's Go Colorado campaign, regarding transportation funding and a proposal to fix Colorado's roads, via sales tax. Proposition 110 will increase the state's sales tax by 0.62%, a little more than half a cent on a dollar purchase.

CDOT currently has more than \$9 billion in unfunded projects.

- Revenue will address longstanding problems with funding transportation projects in the state
- New revenue will be distributed to fund critical state projects that address safety and make it easier to get around.

Schrock presented on Colorado's Economy and State Budget, first highlighting employment, in which Colorado's Total Nonagricultural Employment is outperforming US overall, and the Front Range has one of the best economies with three cities in the Top 10, including Boulder at #1.

He ended with notable budget items for 2018, comprising of:

- Budget Stabilization Factor Decreased \$150 million
- Transportation Funding
- Funding for PERA
- Reserve Increase from 6.5% to 7.25%

The Parkway is named as a tribute to Hogan, who served as Mayor of Aurora for six years, and on Aurora City Council for 24 years prior to becoming mayor. Hogan passed away in May 2018, following a battle with cancer.

The parkway will connect 6th Avenue east of Tower Road to the existing 6th Parkway at E-470. The project is set to be completed by the fall of 2019. ■

change and diabetes education by showing a slide with some Hollywood stars that either have prediabetes or diabetes - to show that the disease can affect anyone, even some who seem healthy and in shape. (Halle Berry (type 2), Nick Jonas (type 1), Alec Baldwin (pre-diabetes), Selma Hayek (gestational diabetes).

The statistics are staggering: 30.3 million people have diabetes, with another 84 million with pre-diabetes. There are risk factors that can't be changed, such as family history, age, and ethnicity; and there are factors that can decrease the risk of diabetes, such as weight control, diet, physical activity, and control of blood pressure.

E-470 Eliminates Vehicle Registration Fee Sept. 1, 2018

Behavioral Economics Lead to Healthier Work Environment

We all know that we should eat better, and while many workplaces are focusing on nutrition education, education alone does not consistently drive behavior change. In a country where 75 percent of the \$3 Trillion spent on healthcare in the U.S. is attributable to conditions strongly influenced by behavior (cancer, heart disease, Type 2 Diabetes, obesity, etc.), and where employers are experiencing an almost 200 percent increase in medical costs for employees with multiple risk factors (<https://goo.gl/CAxZ4f>), behavior change IS the name of the game.

New research from the field of Behavioral Economics suggests that we should focus more on changing workplace "choice environments" than on trying to change employees directly. This approach is compelling because it doesn't depend on robustly funded incentives to reward behavior, or on having the additional bandwidth to develop labor-intensive programming.



Instead, it focuses on changing the choice environment in the workplace. Applications include things like beautifying stairwells to encourage taking the stairs, installing a "walking path" through or around the office for healthier 1:1 walking meetings, and providing fresh fruits & veggies in the workplace.

Behavior Economists Volp & Asch describe it best:

"So many of our conventional approaches to changing the culture of health involve, on some level, trying to convince people that the healthy life is their decision, and one they should choose.

But personal change is hard. The offer of behavioral economics is to meet people halfway. Rather than just aiming to reshape people's behavior to something more health promoting, behavioral economics aims to reshape their context so their existing patterns of behavior are more health promoting. Changing the culture of health may not be easy, but we can advance the goal by modifying choice environments in a systemic way to make the healthy choice the easy choice." (<https://goo.gl/hdNvuc>) ■

2018 Ballot Initiatives Overview

The Chamber is tracking the following initiatives that could be on the November 6 ballot. 98,492 valid signatures are needed for certification; information below is accurate as of 8/27/18. The Secretary of State may certify other measures by 9/5/18.

Citizen Initiated Measures

Amendment 73 – Funding for Public Schools

- Increase income taxes for certain individuals, trusts, estates according to a variable tax rate structure based on annual income,
- Increase the corporate tax rate,
- Reduce residential and nonresidential property tax rates

- Create a fund dedicated to public education from revenue generated by tax increases, and
- Mandate certain actions by the legislature regarding the fund and implementation

**Constitutional Measure – A 55 percent supermajority vote is required for the approval of this initiative*



Proposition 110 – Transportation Funding

- Increase state sales tax rate by .62 percent for 20 years to fund transportation and authorizes
- CDOT to issue up to \$6 billion in bonds

 - o 45 percent for state transportation funding and debt service on the bond repayment;

- o 15 percent for multimodal transportation

The bonds pledged by the VRF were originally approved by the voters in 1988 for the construction and operations of E-470 and were set to be retired in 2026. The E-470 Board refinanced these bonds in 2001 and reduced the final maturity with a scheduled payoff on September 1, 2018, coinciding with the elimination of the fee.

E-470 is the 47-mile, 75-mph toll road running along the eastern perimeter of the Denver metropolitan area. E-470 is a user-financed roadway, receiving no local, state or federal funds for financing, construction, operations or maintenance.




